Currently there is no cure. So her family raises money for research that is being conducted to find a cure and keep her from going blind. All proceeds from this event will be for research to find a cure for Finley's RDH12. Please join us to help us reach our goal of \$250,000 this year so that a search for a cure can continue.*
